Meeting started 7:01pm Discussion for the evening centered around the Ethos Veterinary Clinic that will be located at 5904 Richmond Highway. Ethos is a veterinary health organization with hospitals across the U.S. providing medical care for pets.

The two speakers were Jeff Groth, the director of real estate for Ethos, and Jennifer Garcia. This was an update on their application from the February meeting. The building was purchased in December 2020 by Ethos. It was rezoned from a C-8 to C-3 to accommodate an increase of 7,000 square feet. They will be adding a 6,500 square front addition and adding a 500 foot enclosed area under the main entrance addition. There will be no change in the building height.

The addition of this business will add 142 additional weekly trips to this section of the Richmond Highway corridor.

Ms. Garcia and Mr. Groth discussed connectivity trails for pedestrians from Cameron Run Terrrace and a trail they will be coordinating with Riverside Apartments.

They will be meeting with the Board of Supervisors in mid-July.

Also, Katherine Ward discussed that there will be a meeting to discuss the additional lanes on Richmond Highway on May

3rd. She encouraged all to attend at the Lorton Community Center (where the old Mount Vernon Athletic Club was located).

Mark Viani brought up discussion regarding the county's sitespecific plan (SSPA) process. An email was sent after the meeting specifying opportunities for participation in the process.

# **Special Committee on Stormwater Management**

#### Meeting Minutes May 12, 2022

MSCS dd not hold a meeting in April.

At our May 12 meeting, MSCS team members representing Westgrove, Mount Vee Manor, Stratford Landing, Tauxemont, Williamsburg Manor, and Hollin Hall Village communities attended. The meeting's agenda included the following items:

- · Review of Fairfax County's Public Facilities Manual

# MSCS ACTIVITIES BETWEEN MARCH 15, 2022 & MAY 12, 2022

- MSCS hosted a booth at Supervisor Storck's Environmental Expo on April 23, presenting its activities/accomplishments to date; providing information and contacts on Stormwater (SW) issues; and soliciting those who dropped by to join MSCS efforts
- At the MSCS February meeting, Fairfax County's DPWES stated they were working to better define SW/flooding issues in the County and brief the Board of Supervisors(BoS)in the May/June timeframe. They asked that we hold off on problem site visits until they receive direction from the BoS. MSCS followed up with a request for

status in May. DPWES responded that the engagement with the BoS would likely occur in late summer. On May 11, DPWES provided a copy of correspondence sent to the County Executive, dated May 10, kicking off the review. MSCS analysis of the correspondence and its impact on committee efforts is underway.

- MSCS requested status from Fairfax County's Land
  Development Services on the proposed technical bulletin
  addressing use of stormwater detention devices on
  residential infill projects. MVCCA had submitted comments
  on the draft on November 9, 2021. No response on status
  has been received as of the meeting date.
- With the County's inability to participate in the joint visits to SW problem sites until BoS direction is received, MSCS identified 4 sites to VDOT and requested a VDOT/MSCS visit to those sites. VDOTs response to the request has not been received as of the meeting date.
- MSCS requested Fairfax County Park Authority action on a SW pipe termination in Collingwood Park contributing to yard flooding on Cedar Dale Lane. The County's DPWES responded to the request and a date is being negotiated for the site visit.
- The MSCS co-chair briefed MVCCA Environmental & Recreation Committee (E&R) on MSCS efforts/results to date. An outcome of the briefing was a discussion on how the E&R and MSCS have a mutual interest in SW issues. Larry Zaragosa, an E&R member, who has been involved in environmental issue at the MVCCA and County levels, promoted a coalition among the committees. He also brought up points about the origin and purpose of the revenues produced by the County's SW Tax. He was invited to share this knowledge with the MSCS team and did so at the MSCS May 12 meeting. In brief, the original purpose was to fund SW projects, but over the years revenues have been diverted to support County SW staff functions.

#### **Governing Documents Review**

As a part of its Action Plan, MSCS has committed to a review of existing laws, regulations, ordinances, and guidelines addressing stormwater(SW) management in the County. The review's intent is to identify areas where these governance documents can be strengthened to prevent future SW problems for residents. In its first in-depth review, MSCS focused on Fairfax County's Public Facilities Manual (PFM).

In its introduction, the PFM defines itself as "...guidelines rather than mandates" and "... not to be considered as rigid." It also allows the County's Director, Land Development Services wide discretion in its application. The latitude granted in these statements and the non-mandatory nature of the PFM was a cause of concern to the team, and may remain, subject to

review of other governing documents, a weakness in SW management to be included in MSCS documentation of areas requiring change.

Two PFM chapters - "Geotechnical Guidelines" and "Storm Drainage" were identified as guidance most applicable to the MSCS's work in that they explicitly address areas of SW management. "Geotechnical Guidelines" addresses soil structures and soils testing both of which are important to determine the ability of the soil to dissipate SW. "Storm Drainage" addresses a broad range of topics associated with SW, including policy, types of SW conveyances, computation of system sizes, and engineering type drawings, MSCS focused on elements that directly address residential issues. This included sections on a "Policy of Adequate Drainage"; major and minor drainage system types; a policy for and use of small, private, on-site drainage systems; and drainage in residential areas.

Many of the topics addressed in these chapters are favorable to adequate management of SW, but their application in the real world appear to be missing. Several questions resulted from the discussion; these questions will be posed to County staff:

- Do blanket exemptions exists I.e. has a list of situations, drainage waivers that are pre-approved been published by the Director or that is they are so common, the Director waives them for all building, or buildings in a particular area?
- Are there waivers so common and so frequent that, by convention, are most always waived?
- Is there an understanding by builders that if a particular type of waiver is requested it will most probably be waived?
- Are there zoning requirements that are so outdated, but still on the books that are always waived?
- Is there anything to inform property owners/tenants that wind driven ground water is not covered by the standard homeowners insurance policy?

Given the extensive detail included in these chapters, team members agreed to review the chapters and submit their individual analysis and questions no later than 2 weeks from our May 12 meeting.

### **Next Meeting**

As a prelude to the committees work to educate residents on SW issues, we have invited Northern Virginia Soil & Water Conservation reps to brief the committee at our June meeting. In addition, the committee will do an in-depth analysis of the Fairfax County Zoning Ordinance. The next committee meeting date is TBD.
