#### Supervisor's Report:

The Potomac Banks Tourism project has licked off. The stormwater improvements at the MV Government Center will be completed this year. VDOT is studying extending Express Lanes from Springfield to the Wilson Bridge.

No decision has been made yet on the Huntwood Plaza proposal. Supervisor Storck reminded everyone to complete the survey on the BRT/Richmond Highway widening. The BOS approved Safe Streets (protecting cyclists and pedestrians).

The Council of Governments and the Army Corps of Engineers told Sup. Storck a couple of months ago about their Flood Wall proposal for River View/Belle View/River Towers, and their study will be released on May 27. A community meeting will be held on June 14, 6to 8 pm, at the Belle View Elementary School.

There will be a Penn Daw Fire Station/Homeless Shelter meeting on May 31, and the architect will be introduced.

The Gum Springs Heritage Resources project is finally moving forward.

The Budget for fiscal year 2022-2023 was presented, as was the new proposed dues structure (as published). Both passed unanimously.

The meeting was adjourned at 8:29 pm.

- Ellen: In 2003 had high tide, storm surge and full moon. Had a flood in 1932 before anything was built. In 2003 had \$6.5 million damage in Belle View. Have different restrictions now, not the case back then re: floodplain.

- Larry: Agree with Katherine. We are seeing 100 year floods more frequently. Need to be looking at 500 year floods. Point Ellen made is right about the sewage. Limiting options for flood prevention doesn't make any sense at all.

Earlier this year legislature reversed course and now noise statute for vehicles will be enforced again as primary offense - takes effect July 1. The fact that Fairfax County doesn't

have ordinance on the books is a glaring issue. Mount Vernon Neighborhood College - practicum project. Similar to 2009 resolution having to do with motorcycle noise, but can be easily modified to include all vehicle noise.

Planning and Zoning Meeting June 6, 2022

Meeting was called to order at 7:01 by Chair of Planning and Zoning

Agenda for the evening was two presenters and a vote for a new resolution

The first speaker was regarding 7835 Richmond Highway also known as the "Kramer Property". This is a 2-acre parcel of land in the Gum Springs area. Speakers were owner Rafat Mahmood and Land Use Attorney David Gill.

The property is zoned C-8 and used to be a contractor shop building. Mr. Mahmood would like to build 22 townhomes. Mr. Mahmood and Mr. Gill have already talked to the Gum Springs community. Committee members suggested using the traffic light to alleviate the traffic. As well as concern over cut through traffic. Committee members thought the density of 22 townhomes was too much. Mr. Mahmood and Mr. Gill mentioned that they will be back next fall to discuss more plans and agreed to work with the Gum Springs community. This property will be near the new planned BRT station.

The next speakers were Mr. Evan Pritchard and Mr. Brandon Wright who work with Crescent Communities. They are looking to build multifamily rental units at 8850 Richmond Highway. This is the old IME office building near the Roy Rogers. It is zoned C-8 but backs to wetlands thus having RPA considerations. There are 6 developed acres with 245 units with 20 ADUs/WDUs. There will be public space near Dogue Creek. This will be 3 story buildings.

Crescent will work with VDOT on the Dogue Creek bridge expansion and will work with students at Mount Vernon High School in the development process. Crescent considered structured parking but guidelines in the Woodlawn district do not allow structures over 3 stories. They also mentioned that this will not be economically feasible. The committee suggested applying for a waiver for this constraint.

Lastly, a resolution was passed for the Ethos Veterinary Hospital with no opposition.

A flood mitigation meeting will be held at Belle View Elementary School regarding private land being taken for a wall on Tuesday, June 14, 2022 at 6pm.

Additionally, a committee member brought up about a new project to build 12-16 townhouses in the Huntington area.

MVCCA Transportation Committee Minutes Held jointly with MVCCA Public Safety

June 06, 2022

The Mount Vernon Council of Citizens' Association (MVCCA) Transportation Committee met at 7:00 p.m. on June 06, 2022 in a virtual joint gathering with MVCCA Public Safety (PS) hosted on Zoom. Participating in the meeting were Captain Jonathan Hofflinger, Commander, West District, United States Park Police (USPP); Charles Cuvelier, Superintendent, George Washington Memorial Parkway (GWMP), National Park Service (NPS); Thomas W. Burke, Senior Transportation Planner IV, Fairfax County, Department of Transportation (FCDOT); Pete Sitnik, MVCCA Transportation Committee Chair & Attendance-Taker for tonight's meeting; John Bioty, MVCCA Transportation Committee Note-Taker for tonight's meeting; Jason Zaragoza, MVCCA Public Safety Committee Chair; Bill Kane, MVCCA Treasurer; and Lynn Pascoe, MVCCA Co-Chair.

Transportation Committee representatives from the following MVCCA Associations were in attendance: Belle View Condominium Unit Owners' Association; Holland Court Property Owners' Association; Holland Hall Village Citizens Association; Huntington Community Association; Montebello Condominiums Unit Owners' Association; Mount Vernon Civic Association; Mount Zephyr Community Association; New Alexandria Citizens Association; Riverside Gardens Civic Association; Riverwood Homeowners Association; Spring Bank Community Association; Stratford Landing Citizens' Association; Sulgrave Manor Civic Association; and Waynewood Citizens Association.

Public Safety Committee representatives from the following MVCCA Associations were in attendance: Huntington Community Association; Mason Hill Citizens' Association; Mount Vernon Civic Association; Potomac Valley River Bend Civic Association; and Wellington Civic Association. Total attendance, including several other interested individuals, was 32.

Peter Sitnik, MVCCA Transportation Committee Chairman, called the meeting to order and introduced MVCCA Public Safety Chair, Jason Zaragoza for opening comments. Jason welcomed his Committee members and thanked Peter for organizing the joint meeting.

Chairman Sitnik then made the following announcements:

## **ANNOUNCEMENTS:**

- At this meeting, we are scheduled to hear two (2) presentations (with a possible vote on an 11Y Bus Route Letter of support). We will also discuss one (1) proposed Environmental & Recreation Committee resolution that the MVCCA Board decided must go before all Committees for a review, comment, recommendation, and vote (if needed).
- 2. Thanks to all that attended and participated in the Bus Rapid Transit (BRT) and Turn lane meetings. What we have been calling the "Over widening of Richmond Hwy" with additional thanks to the many comments sent in and hundreds of surveys completed. Over 200 comments were received which should lead to improvements.
- 3. We will consider endorsing a DRAFT letter to Fairfax County (FCC) elected officials asking them to support restarting the 11Y Bus Route (in line with Alexandria's already stated position) during the Yellow Line disruptions starting this fall due to rail line work to connect with Potomac Yard and maintain the Yellow line Potomac River bridge. ### **PRESENTATIONS:**

Proposed letter to Fairfax County on reinstating the 11Y
Bus Service: Chairman Sitnik introduced Kathleen Graham from Sulgrave Civic Association, a former rider of the 11Y.
Kathleen stated that the 11Y was a direct bus service serving Alexandria and the Pentagon but was replaced by the 11C during the Pandemic. She was pleased to learn (from Supervisor Dan Storck's Office) that Metro plans to bring back the 11Y Metro bus service to provide an alternative during Yellow Line service disruptions this fall. In this regard, Kathleen drafted a letter of support for the Committee endorsing this initiative. Wording in the letter, recommends that Supervisor Storck ask Metro to restore the 11Y service permanently. The 11Y would, once again, provide direct service to major employment centers and is faster than driving

or taking a bus to Metrorail. Direct service encourages the use of public transit while transfers and longer commute times create barriers that discourage ridership. In this time of high gas prices, Kathleen explains, this is a reasonable thing to do. ("11Y Letter": see letter at the end of this Record)

Chairman Sitnik thanked Kathleen for her efforts in drafting the letter and recommended adding a section to address environmental impacts. Kathleen agreed. Both Committees supported the letter going forward. Chairman Sitnik then asked for a motion to send the letter to the MVCCA Board of Directors. The motion was made and quickly seconded. The motion carried unanimously by both Committees with no negative votes.

## <u>United States Park Police (USPP) update on the Southern</u> <u>George Washington Memorial Parkway (GWMP):</u>

Chairman Sitnik introduced Captain Jonathon D. Hofflinger, Commander West District, United States Park Police (USPP), for an update on the southern section of the Parkway since implementation of the Road Diet. Chairman Sitnik explained that Captain Hofflinger's discussion would be conversation-based to encourage the exchange of ideas and concerns. He also noted that Charles Cuvelier, Superintendent, GWMP, National Park Service (NPS) was in attendance and may engage in the conversation as well.

Captain Hofflinger stated that although the focus of tonight's meeting was on the southern section of the Parkway, his area of responsibility goes all the way from Mt Vernon to the American Legion Bridge intersection. For the southern portion of the GWMP, Captain Hofflinger showed crash/incident data slides that divided the Parkway into three sections (1) Mt Vernon to Collingwood, (2) Collingwood to Tulane and (3) Tulane to Old Town. His data stretched from 2019 to the beginning of 2022. His charts included categories such as PI (personal injury), PD (property damage), (F) fatality, FV (Force "Agency" Vehicle) and PDO (property damage only). He mentioned that the 2019 pre-pandemic data is a better comparison to what we're seeing now in 2022 as the pandemic subsides and traffic flows return to normal. After discussing 2019 statistics versus what has been tabulated thus far for 2022, Captain Hofflinger said data is looking similar. He did state that although there have been no fatalities on the southern section of the Parkway thus far in 2022, he did acknowledge that concerns are real.

One Committee member asked about the volume of traffic on the southern section of the Parkway. He made the point that tabulating incidents/accidents without documenting volume was less than optimum. Captain Hofflinger said that tabulating volume was not his responsibility. NPS Superintendent

Cuvelier agreed and said it was an NPS' job to do and there's data on the NPS website that talks to volume. Another Committee member brought up a concern over the Collingwood intersection. He said vehicles race to get ahead of others before reentering the Road Diet area again. NPS Superintendent Cuvelier noted the concern and said that NPP Officers were made aware of this issue. Another Committee member said speeding on the Parkway has not changed. While still others sited that speeding in the one lane areas of the Parkway was lower. People rarely travel the speed limit and often speeds in excess of 60 mph are noted. Speeding is not "rush hour dependent" he said; it occurs throughout the day. This statement led to the issue of enforcement, or lack of it, on the southern section of the Parkway. Captain Hofflinger mentioned that he was bound to enforce areas where most incidents or accidents occur and the southern section of the Parkway was less problematic. When asked about manpower shortages, Captain Hofflinger said, on a daily basis, there would be one USPP Officer assigned to patrol the southern section of the Parkway. Superintendent Cuvelier added that shortages are real and many law enforcement agencies are experiencing manpower shortages at the moment. He added that NPS/USPP is looking to hire 72 Officers next year, but it takes 9 to 10 months before that person actually hits the street. Captain Hofflinger noted that the USPP's current strategy is to become more efficient with the current force.

Several Committee members stated that right-of-way turnoffs at Belle Haven were still a concern and that folks were now using Fort Hunt Road rather than negotiate traffic at the Belle Haven intersection. Several other Committee members referenced line of sight issues with trees and bushes that need pruning. Downed trees from the January 2022 snowstorm still need to be cleared. Another Committee member raised the possibility of using speed cameras on the southern section of the Parkway. Chairman Sitnik noted that MVCCA's Transportation Committee recommends the use of speed cameras on the Parkway and understands it will take a concerted effort by all stakeholders to achieve it. Superintendent Cuvelier interjected that Parkway fines are deposited in the US Treasury and do not go directly back to support NPS or NPP. He did mention a recent pilot program in San Francisco introduced speed cameras on National Park Roadways and that we may hear more about that in the future. Chairman Sitnik made it known that the Committee will continue to work with Congressional Representatives to employ speed cameras on the Parkway.

Superintendent Cuvelier also mentioned a very recently released initiative/action by the Department of the Interior (DOI), Office of the Secretary, Strengthening Public Trust in DOI's Law Enforcement Program. He highly encouraged and recommended all engage in this effort. (PDF Strengthening

**Committee Reports** 

Both NPS Superintendent Cuvelier and USPP Captain Hofflinger thanked the Committees for the opportunity to engage on GWMP safety concerns. Public engagement, they stated, is important to their role of keeping the Parkway as safe as possible under the current situation. In turn, Chairman Sitnik thanked both men for their time and attention to address Committee issues and vowed to keep the lines of communication open.

In summary, it was apparent to both Committees that not much has changed from what has been said before. Both Committees have issues with speeding and reckless driving on the southern section of the Parkway. The Committees believe, however, that USPP and NPS officials are doing their best to address these concerns with the current personnel shortages. Of the three pillars to the Parkway Safety Study released in September 2021(engineering, enforcement and education), it is the Committee's opinion that enforcement is still lacking on the southern section of the Parkway. Something needs to change since the southern section of the Parkway is so heavily populated.

Review discussion (considering alternatives), and voting on a Proposed Environmental and Recreation (ER)
Committee Resolution requiring Fairfax County (FCC) to add an additional website to better inform FCC Citizens of Boards, Authorities and Commissions (BAC)s.

In reference to ER's proposed resolution requiring FFC to add an additional website to better inform FCC's Boards, Authorities, and Commissions, the MVCCA Board directed that the Resolution be reviewed by a larger audience because if affected all MVCCA Committees. The Board asked Committees to review, comment, make recommendations, and if required, vote on a an outcome to either: (a) vote to support, (b) vote not to support, (c) send back to ER for refinement, (d) instead of a Resolution, send a letter to the BOS asking the BACs to do a better job of informing the public or, (e) invite FFC expert to address the ER Committee so they are better informed and then have them reconsider the Resolution.

Chairman Sitnik began the discussion by saying that he felt the Board was correct to say that the Resolution should be discussed and voted upon by all Committees. He also gave his personal opinion and knowledge that many BACs already post appropriate notices and meet compliance requirements based on the legal opinion of FFC attorneys. It is also possible that not all BACs fully meet the standards and requirements. Chairman Sitnik said the operable question is: will citizens look at separate website to find information or is it better to ensure that boards and commissions post relevant information on their own existing webpage? Chairman Sitnik felt that tightening up

on postings and notices is the way to go rather than create an additional website. He suggested that addressing individual Committee posting shortfalls could resolve the problem without an additional website. Chairman Zaragoza agreed with Chairman Sitnik and said the thing to do is to encourage Fairfax County to quickly address the shortcomings of any individual BAC and require those individual BACs to do a better job at posting timely, relevant information, and general compliance issues.

When brought to a vote, both Committees agreed that instead of a vote for the Resolution, sending a letter from the MVCCA Board to BOS asking the BACs to do a better job of informing the public in a timely manner was the way to go. This motion passed unanimously by both Committees with no negative votes. It was also suggested that FFC representatives could be invited to a General Council or Committee meeting to give an update of their current situation and then readdress as necessary.

#### New Items:

None introduced

### **Meeting Adjourned:**

Without new business, Chairman Sitnik asked for a motion to adjourn. A motion was initiated and quickly seconded. Chairman Sitnik thanked Chairman Zaragoza and Public Safety for attending tonight's meeting. He also thanked all presenters and joint Committee members for sharing their thoughts, interest and concerns to MVCCA related items. The joint Transportation and Public Safety meeting concluded at 8:17 PM.

## 11Y Letter

Dan Storck, Supervisor, Mount Vernon District Fairfax County Board of Supervisors

Subject: 11Y Metrobus Service, request support permanent restoration of full 11Y service.

We were pleased to learn from staff in your office that Metro plans to restore 11Y bus service as an alternative during the Yellow Line service disruptions in Fall 2022. We strongly support this option and ask that Fairfax County support permanent restoration of full 11Y service. The 11Y provides direct service to major employment centers (1) and will be needed by Mount Vernon residents as Federal agencies transition to in person work. The 11Y is faster than driving or taking a bus plus Metrorail. Direct service encourages the use of public transit, while transfers and longer commute times create barriers that discourage ridership. Before the pandemic, the 11Y was one of the more profitable routes.

Workplaces served by the 11Y include the Departments of Agriculture, Commerce, Interior, State and Treasury; the Smithsonian; the Holocaust Museum; the Environmental Protection Agency; the US Agency for International Development; the Office of Management and Budget; the Office of Personnel Management; the World Bank; the International Monetary Fund; the Federal Reserve; and major law firms and non-profit organizations. As well as other businesses in the DC metro area and the City of Alexandria.

The 11Y will become even more attractive as gasoline prices continue to rise. If commuters are able to resume riding the 11Y permanently, their commute will produce less carbon dioxide emissions. Additionally, the presence of direct service enhances property values in communities near the route.

#### **Background**

On July 7, 2021, Secretary Deb Haaland announced the establishment of a new departmental law enforcement task force to implement the highest standards for protecting the public and provide necessary policy guidance, resources, and training to agency personnel within the DOI. Led by Deputy Secretary of the Interior Tommy Beaudreau, the Task Force is responsible for implementing the Secretary's vision of utilizing an equity lens and evidence-based decision making to review and identify opportunities for improvement in law enforcement programs of the National Park Service, U.S. Fish and Wildlife Service, Bureau of Land Management, Bureau of Indian Affairs, and Bureau of Reclamation. The Task Force will focus on ways to (1) strengthen trust in our law enforcement programs; (2) ensure appropriate policy and oversight is implemented; and (3) ensure supportive resources are available for officer mental health, wellness, and safety.

A working group of subject matter experts, representatives of Bureaus with law enforcement programs, Bureau of Reclamation, and the DOI's Office of Law Enforcement and Security identified both internal and external key stakeholders that will inform this process. External stakeholders will include members of the public, visitors,

advocacy groups, cooperating state and local organizations, neighbors and community members, and members of Tribes. With the goal of providing recommendations to improve the law enforcement programs within the DOI, the working group seeks input from these key stakeholders on DOI law enforcement services and areas for possible improvement.

DOI is conducting twelve (12) virtual listening sessions and inviting public comments to obtain stakeholder input on public perception of DOI law enforcement and understand how the DOI can best develop and maintain public trust, transparency, and legitimacy with its stakeholders.
