Fairfax County Zoning Administration Division: Sara Morgan, Senior Planner and Carmen Bishop, Deputy Zoning Administrator

The meeting regarding a proposed Zoning Ordinance Amendment started at 7:05 p.m.

It was a comprehensive review of the landscaping and screening provisions of the zoning ordinance and changes to parking lot landscaping, transitional screening and barrier requirements. Review is currently underway with an interagency work group and will continue with the assistance of a consultant, over the next few months.

After the presentation Ms. Morgan asked for public input and comments on possible changes to the Ordinance. She asked:

- Should we look at a lower number than 20 spaces as the threshold for parking lot landscaping? and or increase the percentage of parking lot landscaping?
- Require a landscape island every [#] of parking spaces?
- Consider shade tree requirements for travel aisles?
- Modify the width and planting requirements of transitional screening?
- Examine the need for barriers?
- Consider the implication of solar canopies?
- Other suggestions?

#### DISCUSSION:

Committee member asked what drove this presentation? Was any of it driven by development at Bellevue where trees were removed that were 100 years old and took away 75% of shade in the area. The trees were completely decimated. Lack of shade in this changing climate is very dangerous.

Ms. Morgan and Ms. Bishop stated that their review was not driven by this, but that those issues do need to be addressed with the Land Development Services.

Committee member asked would there be direction given on the types of trees to be used in parking lots? Suggestions such as Crepe Myrtle trees make sense because you don't want seed bearing, fruiting, pods that attract birds and make it unsanitary. Ms. Morgan stated that they would definitely be looking at Native vs. Invasive plantings as a priority and would be guided by the experts. Also the use of Resource Protection Area (RPA) is addressed in the Amendment.

Ms. Bishop said it was important to look at intense vs. less intense use but that Tree Preservation is a different chapter of Zoning to consider and not in this Amendment.

Committee member suggested that lowering the number of parking spaces to anything less than 20 would be helpful.

Committee member said the same situation has been seen at 7800 Richmond Highway as that of Belleview. They came and cleared out the trees. She was interested in when the Amendment will go into effect and would the tree issue be on a building permit. Would there be penalties for such acts?

Ms. Bishop: For these situations where trees are being cut down, there needs to be an approved grading plan. The starting point is a grading plan.

Site and entitlements penalties would need to be implemented. Issues would need to be fixed and trees would need to be replaced.

Committee member commented that the Military has been doing Solar Canopy and they are very useful. They have also been doing portions of lots as pervious surfaces.

Realizing that pervious surfaces are not part of this amendment but suggest they need to be studied because maintenance is an issue.

Ms. Morgan: We have not addressed pervious but also not required in Amendment.

Committee member asked if there any provisions for redevelopment (for example the Belle View Shopping Center)?

# JOINT Public Safety Transportation

MVCCA Transportation Committee Minutes Was held jointly with MVCCA Public Safety

December 05, 2022

The Mount Vernon Council of Citizens' Association (MVCCA) Transportation Committee met jointly with MVCCA Safety at 7:00 P.M. on December 5, 2022 in a virtual gathering hosted on Zoom. Participating in the meeting were Noah Simon, State Representative Don Beyer's Chief of Staff; Charles Cuvelier, Superintendent, George Washington Memorial Parkway (GWMP), National Park Service (NPS); Mark Maloy, Acting Chief of Staff, GWMP, NPS; Houda Ali, PMP, District Assistant Director, Transportation & Land Use for Fairfax and Arlington

Counties. Virginia Department of Transportation (VDOT); Thomas W. Burke, Senior Transportation Planner IV, Fairfax County, Department of Transportation (FCDOT); Vanessa Holt, PE, PTOE-Engineer IV-FCDOT; Erika Christ, On the Move News; Pete Sitnik, MVCCA Transportation Committee Chair & Attendance-Taker for tonight's meeting; Jason Zaragoza, MVCCA Public Safety Committee Chair; John Bioty, MVCCA Transportation Committee Note-Taker for tonight's meeting; Bindu Mathur, MVCCA Planning & Zoning Chair; Bill Kane, MVCCA Treasurer; and Lynn Pascoe, MVCCA Co-Chair.

Transportation Committee representatives from the following MVCCA Associations were in attendance: Belle View Condominium Unit Owners' Association; Holland Court Property Owners' Association; Huntington Community Association; Mount Vernon Civic Association; Mount Vernon Manor Citizen's Association; New Alexandria Citizens Association; Riverwood Homeowners Association; Stratford Landing Citizens' Association; Sulgrave Manor Civic Association; Wellington Civic Association; and Westgrove Citizens Association.

Public Safety Committee representatives from the following MVCCA Associations were in attendance: Collingwood on the Potomac; Huntington Community Association; Mason Hill Citizen's Association; Mount Vernon Civic Association; and Potomac Valley-River Bend Civic Association.

Total attendance for the joint meeting, including several other interested individuals, was 28.

Peter Sitnik, MVCCA Transportation Committee Chairman, opened the meeting by thanking all those who were in attendance. He stated that after seven (7) years as the Transportation Committee Chairman, he found it necessary to move on. He announced that anyone interested in assuming the position of Transportation Chairman should contact one of the MVCCA Co-Chairs.

Chairman Sitnik also introduced Public Safety Chair, Jason Zaragoza who welcomed his Committee membership.

Chairman Sitnik noted that since announcements had been previously sent with read-ahead material, he would not repeat them again.

#### **ANNOUNCEMENTS** (listed for record purposes only):

1. NPS recap of the Nov 30 Meeting: Bell Haven & Belle View intersections. NPS has reviewed the combined concerns and recommendations of the New Alexandria Citizens' Association (NACA) as well as MVCCA's Transportation Committee to quickly make short term safety improvements to the Belle Haven & Belle View intersections. The Nov 30 NPS virtual meeting was

moderated by Noah Simon, State Representative Don Beyer's Chief of Staff and was supported by Charles Cuvelier, Superintendent, NPS, GWMP. This is our second chance to hear NPS' information. A vote may be taken tonight to write a letter or draft a resolution in support (or not) of NPS' recommendations.

- 2. On Dec 6 NPS will host an on-line meeting regarding a proposed plan and environmental assessment to improve the Southern Section of the GWMP and the Mount Vernon Trail. The project would improve long term safety concerns and address maintenance needs along the Parkway and the Trail. A vote may be taken tonight to ask the MVCCA Board to write a letter or draft a resolution in support (or not) of NPS' initiative.
- 3. NPS & MVCCAA Memorandum of Understanding (MOU). The long anticipated formal agreement establishing a partnership between the NPS and the MVCCA was signed by all parties on November 18, 2022. The main thrust of the MOU is to promote safety on the GWMP (the MOU is posted here on the MVCCA website under the News section).
- 4. **Update on GWMP Routine Maintenance**: During the South Parkway Safety Study, several routine maintenance activities were identified for NPS to address.
- 5. **Please welcome Mark Yonchak** the new Transportation Committee Representative from the Mount Vernon Civic Association, replacing John Reiser who recently moved.
- 6. **Aircraft Noise Update:** The MOU on Aircraft Noise Mitigation Study between Prince George's County, Fairfax County and the City of Alexandria is currently in its final stages and may be signed shortly.
- 7. At our upcoming Jan 9, 2023 meeting, we anticipate hearing from VDOT and FCDOT on the results of the Richmond Hwy (Rt-1) Widening/Turn Lane Analysis/Bus Rapid Transit (BRT) Study. We hope to learn of the resulting footprint of the roadway, both in the widening area and the BRT corridor.

#### PRESENTATIONS:

GWMP Intersection Changes at Belle Haven Road and Belle View Boulevard: Chairman Sitnik introduced Noah Simon, Chief of Staff for State Congressional Representative Don Beyer. He was supported by NPS Superintendent GWMP, Charles Cuvelier, NPS. Chief of Staff Simon began by saying

that Congressman Beyer was extremely interested in safety on the GWMP and took public complaints to heart. He mentioned that the Congressman was instrumental in bringing about the GWMP Safety Study which occurred in 2021. He noted that many of the changes implemented as a result of the Safety Study were positive but issues continue at Belle View Boulevard and Belle Haven Road Intersections. He acknowledged receiving NACA's June 28th letter pointing out serious issues and requesting immediate changes to the Belle Haven Rd. Intersection. He mentioned that he and GWMP Superintendent Charles Cuvelier talk weekly and recently more and more about the aforementioned intersections. He recapped the previous November 30th NPS Public Meeting where 108 interested citizens tuned-in, noting that four options were presented at that meeting as possible solutions. He mentioned that a meeting earlier in the year was held to obtain public intersection concerns at Belle Haven Rd, and Belle View Blvd. however the November 30th meeting was intended to discuss what NPS was going to do to fix the problem. Chief of Staff Simon then turned the meeting over to GWMP Superintendent Charles Cuvelier who showed his Option 3 Slide which addressed NPS' proposed fix to Belle Haven Road Intersection. Option 3 fix includes a single North-bound lane through the Intersection (i.e. a lane reduction from the current two lanes) as well as acceleration/deceleration lanes and restriping.

**Discussion:** Chairman Sitnik led the discussion by mentioning that during NPS' November 30th Virtual Public Meeting, several suggestions, including a hybrid option, were discussed by local residents. He asked whether those were presented to NPS engineering for study. Superintendent Cuvelier stated that they were documented. He added that NPS is reluctant to design something that won't work. Chairman Sitnik again surfaced the idea of a road diet in the vicinity of both Belle Haven and Belle View intersections. This idea appealed to the Committee members, however, Superintendent Cuvelier did not respond to that comment. Another member asked about accident documentation after the Road Diet was incorporated and whether traffic modeling would have to done before Option 3 could be incorporated. Superintendent Cuvelier stated that NPS would use due diligence before beginning work to modify the intersection – namely, traffic volume and congestion modeling before implementing Option 3.

At the conclusion of the discussion period, Chairman Sitnik gave Superintendent Cuvelier an opportunity to plug their GWMP/Mount Vernon Trail upcoming virtual public meeting. Superintendent Cuvelier stated that on December 6th at 7 PM, NPS would be seeking public comment on a proposed plan and environmental assessment to improve the southern portion of the GWMP and the Mount Vernon Trail. The project, he mentioned, is intended to improve safety and address

maintenance needs along the Parkway and the Trail. He welcomed all to dial in to the virtual meeting and added that NPS would take written comments through Jan. 4, 2023.

Chairman Sitnik thanked Superintendent Cuvelier and Chief of Staff Noah Simon for their time and effort in addressing GWMP intersection issues. Chairman Sitnik also noted that the long-awaited formal agreement (MOU) establishing a partnership between the NPS and the MVCCA was signed by all parties on November 18, 2022. The main trust of the MOU is to promote safety on the GWMP.

Chairman Sitnik then discussed the idea of whether the Committees should draft a proposed resolution, or a letter, asking NPS to consider Nov 30th hybrid options to correct Belle Haven Rd. intersection deficiencies. Joan Darrah, from New Alexandria Citizens' Association (NACA), reported that her Association had already written a letter asking the same thing. As a result of Joan's comment, a Committee motion was introduced to endorse NACA's latest letter dated December 2<sup>nd</sup>. advocating much-needed safety improvements to the Belle Haven Road intersection and consider improvements to Belle View Blvd, as well. It was also agreed that a hybrid design should be considered that included north-bound road diets that provided a safe haven for vehicles at points of conflict. This motion was quickly seconded and a combined Committee vote was taken. The motion passed with no negative votes and only one abstention. It was also recommended that the proposed endorsement letter be presented to the Board at the next meeting (Thursday Dec 8th, 2022).

# NPS Proposed Plan and Environmental Assessment to Improve the Southern Portion of the GWMP and the Mount Vernon Trail:

Chairman Sitnik introduced a motion for the MVCCA to endorse NPS' planned effort to improve the Southern Portion of the GWMP and Mount Vernon Trail. This, he claimed, could be an important step leading to the implementation of much needed long-term safety improvements and could address maintenance needs along the GWMP and the Mount Vernon Trail. This endorsement could feature the implementation of a new road diet which reduces lanes through pavement striping in order to improve vehicular safety. In some areas, recommended crosswalks and intersection changes could be implemented. With respect to the Mount Vernon Trail, potential safety enhancements could include widening and intersection improvements. With reference to NPS' current intersection plan (Option 3), for Belle Haven Rd., the letter could emphasize a better design and suggest improvements to Belle View Boulevard as well.

<u>Discussion:</u> Committee members agreed that this was an excellent idea and another way to promote overall safety in the

Mount Vernon Area. A motion was raised to draft a letter from the MVCCA Board thanking NPS for its initiative and endorsing the overall effort. This motion was quickly seconded and a Committee vote taken. The motion passed with no negative votes and only one abstention. Again, since timing was considered an issue, it was suggested that the letter should be presented to the Board at the Dec. 8th meeting.

#### Resolution in Support of George Washington Memorial Parkway 10 Foot Easement

Chairman Sitnik introduced Jan Smith from Wellington Civic Association who addressed the Committees on a proposed resolution regarding three (3) vacant properties alongside the right side of the Parkway at Northdown Rd. (in the vicinity of the Stone Bridge). For background information, Jan mentioned that these houses have been vacant for some time and that the owners originally desired that this property be donated to the National Park Service in order to maintain the 10 foot easement along the Parkway. This, she said, would ensure pedestrian and bicycle safety along the Mount Vernon Trail and GWMP. The land, however, has since come under the ownership of the National Park Foundation who intends to sell the properties. Jan is concerned that when these properties are sold for profit by the Foundation, the 10 foot easement and related safety easements would disappear. One property, 7703 Northdown Rd. has already been listed by Redfin for sale. Jan mentioned that Katherine Ward, MVCCA Co-Chair was instrumental in drafting a first cut on a proposed Resolution. The Resolution, with editorial changes, would have MVCCA stipulate that, regardless of sale, owners must recognize, and abide by, the 10 foot easement along the GWMP to ensure safety of pedestrians and bicyclists.

<u>Discussion:</u> Upon hearing Jan Smith's discussion, a Safety Committee member raised a motioned to support the proposed resolution with editorial changes. This motion was seconded and a vote was taken. The vote to support the Resolution was unanimous with no negative votes.

#### New Items:

Chairman Sitnik asked Committee members to think about submitting applicable items for next years' Monthly MVCCA Transportation meetings. These, he stated, could be topics like Hot Lanes on 495 or other transportation topics which may or may not involve Board action.

#### **Meeting Adjourned:**

Without new business, Chairman Sitnik asked for a motion to adjourn. A motion was presented and quickly seconded. Both Chairman Sitnik and Chairman Zaragoza thanked all presenters and joint Committee members for sharing their

### Transportation/Planning & Zoning

Proposed MVCCA Resolution: Bike Path and Northdown Rd, Alexandria, VA 22308 Safety Condition Improvements (Transportation and Public Safety) TRAN/PS-2022-01

Whereas: A section of the George Washington Memorial Parkway bike path that runs through the Mount Vernon Council of Citizens Association's (MVCCA) member community, The Wellington Civic Association, opens onto Northdown Rd, requiring bikers, joggers, children walking to the school bus, and dog walkers to mingle with 2-way traffic along Northdown Rd. as they head south to reconnect with the actual bike path;

Whereas: Northdown Rd is narrow with no shoulders:

Whereas: The lack of a designated and identifiable bike path on Northdown Rd creates a very unsafe situation for multiple reasons - speed of the autos, failure of many drivers to stop at the Alexandria Bridge stop sign before turning onto the Northdown Rd, and numerous driveways from homes along the east side of Northdown Rd;

Whereas: The National Park Foundation intends to sell 3 buildable properties, once owned by Harry Lyons, on the west side of Northdown Rd (7722,7714,7704); The Lyons Trust wanted the property to be enjoyed by all;

Whereas: This sale will create more unsafe conditions due to more active driveways being created (the existing current homes have been vacant for over 8 years); and

**Whereas:** The National Park Service will be expanding/widening the GW Memorial Bike Path in the near future to at least 10 feet to encourage more pedestrian, bikers etc. to use the path for recreation and commuting.

**Therefore, Be It Resolved:** To mitigate the safety concerns on Northdown Rd we are requesting the following:

- 1. That the bike path be extended onto the properties on the west side of the road and that that stipulation be placed into the real estate listing as a disclosure of sale. The path can be placed on the NPS easement that they have along Northdown Road's west side and these properties.
- 2. All proceeds from the sale of these properties must be used only for the betterment of the parkway and park property within the boundaries (Southdown Rd. to Collingwood Rd.) of the MVCCA's member the Wellington Civic Association to include Northdown Rd safety improvements.
- 3. That crosswalks be painted across the Northdown Road's entrance to the GW Parkway;
- 4. Clear indications as to the bike path's location needs to be established with paint or bollards.
