**SFDC** - The Safeway site on Richmond Highway has been sold and something will be going into this space. Unsure of what will be going in to the site and no meeting participants know as of the date of the meeting who purchased or what development will be opened at the site. Exec. Director is working on things to help Small Businesses and also looking for a few authors to participate in book readings.

**Fairfax County Federation of Citizen Associations** - officers were elected on 25 May and also formed a bylaws committee. Larry Green was elected the 2nd Vice President who is a resident of Mount Vernon District as well as Morgan Jameson. There will be a picnic held 22 June at the Mason District Park that starts at 6:30pm.

**Stormwater** - did not meet as they are waiting for the Fairfax Stormwater Policy to be rewritten. There will possibly be some new ordinances aimed at Homeowner Associations for a pilot of private to public ownership of ponds in the county with the goal of the county taking over the responsibility of the maintenance. Stormwater work has been delayed until November 2023. Nick indicated that there needs to be hearings to potentially establish funds and looking for a September 2023 date for the meeting.

**Education:** - Chair was not in attendance and they did not meet this last month - proposal is in place to start meeting in person.

**Transportation:** Did not meet in June. The National Park Service approved the plans for the intersection of the Parkway and Bell Haven Road. Bridge repair has been postponed due to migratory birds nesting under the bridge. Discussion also focused during the meeting about the National Park Service not reporting accidents on the Parkway. There was also a question about potential speed cameras and if they could be used to assist with speeding.

### Environment & Recreation

5 JULY 2023 – E&R Committee Meeting Notes

The meeting was called to order at 7:03pm by the Chair Larry Zaragoza. MVCCA Cochair Katherine Ward, and E&R Recorder Christina Curley were in attendance.

Associations represented: Spring Bank Community Association, Hollin Hall Village Citizens Association, Huntington Community Association, Belle Haven Terrace Civic Association, Collingwood-on-the-Potomac, Belle View Condominium Unit Owners Association, Stratford Landing Citizens Association, Mount Vernon Civic Association, Wellington Civic Association, and Potomac Valley-River Bend Civic Association.

Chair Larry Zaragoza led discussion on a draft Stormwater Management Assistance Fund resolution. Recently the Board of Supervisor's Office authorized the advertisement of a local

\$250K Stormwater Management Facility Assistance Grant Program in advance of a September 12, 2023, hearing on the matter. The Committee voiced several concerns, the foremost was the belief that the County should finalize its revisions of the overarching Stormwater Policy, currently anticipated in Nov 2023, prior to the creation, roll-out, and vote on the Stormwater Grant Program. Additional concerns raised included the lack of program details on grant nomination and prioritization processes; sufficiency of grant sizes (believed to be less than \$10K per grant); potential burden of cost sharing requirements; and need to clarify and deconflict roles between County and NOVA Planning District Commission. Committee revised the draft resolution to reflect discussion. Ellen Young voted in favor of the revised resolution; Anita Kerr seconded the motion. Vote was taken; all members were in favor.

Chair Zaragoza introduced a new draft Living Shorelines Resolution. Overarching intent of resolution is to document significant negative impacts of the 2020 Living Shoreline State Legislation implementation on constituents to inform State Legislators, and serve as an impetus for them to seek revisions. Given that the resolution included a reference to impacts to the owners of a waterfront property in South County, Chair Zaragoza suggested that we wait until the South County Federation has passed their resolution before adopting a resolution along the lines presented.

Kevin Knappmiller (Spring Bank) briefed the current status of Quander Fairchild Trail efforts and introduced a draft resolution. The new county trail staffer is scheduled to meet at the park for a walk-through on July 15th, therefore, he asked the Committee to hold off on voting on the resolution. It was agreed that he would share the preliminary list of expectations for trail improvements with county staff.

Chair Zaragoza updated the Committee on Data Centers. The Board of Supervisors recently directed staff to study Data Centers and review some items identified during EQAC a recent engagement, such as proximity to residential areas, options for noise reduction methods, and water use impacts.

Finally, Chair Zaragoza noted that there will be an upcoming hearing before the Board of Supervisors and the Planning Commission and the county is still open to comments.

A motion to adjourn was made, seconded, and passed at 8:24 pm. There will not be a E&R Committee meeting in August. The next E&R Committee will be on 06 SEP 2023 via Zoom.

Ms. Mariska discussed development of the property at 8727, 8729, 8733 Lukens Lane. Her client is requesting rezoning from R-2 to R-3 to permit development of 12 single family dwellings. This property is just over four acres and is three parcels. The homes will be served by a central street. Each home will be about 2500 square feet.

Ms. Mariska mentioned that the plans were accepted a few weeks ago but have not received feedback from the county yet. She also mentioned that the plans were early in the process, and they expect to come back to MVCCA again. The project expects to go to the Planning Commission on December 13th but no Board of Supervisor date has been set.

Committee members discussed in detail the tree canopy and noted their issues regarding clear cutting the area. Speakers noted our issues. They also mentioned that a developer has not yet been set.

We also discussed the status of several projects including the following:

Huntington Ave. (Planning Commission meeting has been deferred to November 15th)  
Infill Task Force (Committee suggested reinforcing our position by writing a letter to the Board of Supervisors)

There is no scheduled meeting for August. The next P&Z meeting will be on August 28th. This will be the September meeting since our regularly scheduled meeting day falls on a holiday.

## Transportation

The Mount Vernon Council of Citizens' Association (MVCCA) Transportation Committee met on July 10, 2023 in a virtual gathering hosted on Zoom. Participating in the meeting were Jason Zaragoza, MVCCA Transportation Committee Chair & Attendance-Taker for tonight's meeting; John Bioty, MVCCA Transportation Committee Note-Taker for tonight's meeting; Queenie Cox, organizer for the Virginia historical highway marker for West Ford; Katherine Ward and Lynn Pascoe, MVCCA Co-Chairs, and Bill Kane, MVCCA Treasurer. Transportation Committee representatives from the following MVCCA Associations were in attendance: Belle View Condominium Unit Owners Association; Holland Court Property Owners' Association; Hollin Hall Village Citizens' Association; Huntington Community Association (Chair); Montebello Condominium Unit Owners' Association; Mount Vernon Civic Association; Mount Vee Manor HOA; Potomac Valley-River Bend Civic Association; Riverside Gardens Citizens' Association; Riverwood Homeowners' Association; Stratford Landing Citizens' Association; Sulgrave Manor Civic Association; Waynewood Citizens' Association; Wellington Civic Association; and Wellington Heights Civic Association. Total attendance for the joint meeting, including several other interested individuals, was 20. Chairman Zaragoza noted that announcements had been sent out with the "read-ahead".

**ANNOUNCEMENTS & AGENDA (listed for record purposes only):**

- Updates on George Washington Memorial Parkway (GWMP)
  - Improvements to Belle Haven intersection were approved but the timeline remains unknown. Work is tied to the repair of Mount Vernon Trail Bridge No. 23, which is on hold due to a bird's nest in the vicinity.
  - National Park Service (NPS) and Fairfax County Department of Transportation (FCDOT) are working to install two bike-share stations along the Mount Vernon Trail (MVT) to help alleviate the issue of discarded bikes littering the trail. They are also working to install speed signs on the MVT.
- Huntington Ave. road diet study has been postponed due to VDOT's current moratorium on all road diets.

- Member / new business time will be allotted at the end of this meeting.

MVCCA's Transportation Committee Chairman Jason Zaragoza began the meeting at 7 PM and welcomed all attendees. He announced that there would be no formal presentation this evening since he has had difficulty getting NPS to respond to invitations regarding Parkway Improvements – specifically Belle View and Belle Haven Intersections.

**PRESENTATIONS:** No formal presentations at the July 10<sup>th</sup> meeting.

## **AGENDA ITEMS:**

### **Belle View Boulevard and Belle Haven Road Improvements on the Parkway:**

Chairman Zaragoza led off this discussion by indicating Parkway improvements for Belle Haven Road and Belle View Boulevard have been approved but the time line for incorporation is TBD. Work is tied to the repair of Mount Vernon Trail Bridge No. 23, which is on hold due to a bird's nest in the general vicinity. Chairman Zaragoza mentioned improvements could take as long as November as a result of the bird nest. He mentioned that Belle Haven Road would have an acceleration lane with accompanying bollards but that he did not know the length of the acceleration lane. It is hoped that NPS will respond to future Transportation requests for information so that MVCCA could be kept up to speed on Parkway improvements.

**Discussion:** Several members reported that Belle Haven Road and Belle View Boulevard Intersections continue to be a “cause for concern” on the George Washington Memorial Parkway (GWMP) and until those are fixed, they are problematic with a risk posed to both vehicular and pedestrian traffic. There was a consensus from the Committee on that statement.

### **Bike Share Stations along the Mount Vernon Trail**

Chairman Zaragoza reported that NPS and FCDOT are working to install two bike-share stations along the MVT to help alleviate the issue of discarded bikes littering the trail. They are also working to install speed signs on the MVT. He mentioned that it would be appropriate for the Transportation Committee to comment on this proposal – either for or against. Chairman Zaragoza mentioned that these bike stations would be for

conventional bikes, much like the bike rentals in Old Town Alexandria.

**Discussion:** The topic was debated by several Committee members – many who indicated that they observed bikes littering the MVT in several locations. Initially it appeared that Committee members supported the ideas of bike stations to help police the MVT but some members had a different viewpoint. Noting that the MVT had a cultural and beautifying aspect to it, Many Committee members felt that the positioning of Bike Share Stations would actually increase, vice decrease, the possibility of bikes littering the MVT. After much back and forth discussion, to include pedestrian usage of the MVT, Chairman Zaragoza asked for a motion to vote on a resolution to either support or oppose NPS' & FCDOT's initiative to erect two (2) Bike Share Stations along the MVT. Ultimately, a resolution was brought to the floor OPPOSING the erection of Bike Share Stations along the MVT for fear that it would add, vice solve, bike littering on the MVT. The Vote was 9 in favor (of opposing Bike Share Stations) and one (1) against. The resolution OPPOSING Bike Share Stations along the MVT Passed overwhelmingly.

### **Huntington Avenue Road Diet Study and VDOT's**

#### **Moratorium:**

Chairman Zaragoza reported that VDOT has issued a current moratorium regarding Road Diets, therefore the Huntington Avenue Road Diet Study is being held up.

Historically, Chairman Zaragoza mentioned that Fairfax County considered a “Road Diet” Study for Huntington Ave to improve pedestrian and cyclist safety. The study would cost \$50,000. For information, Huntington Ave has two lanes in each direction (East & West). VDOT's initial though was to reduce the 2 lanes (in each direction) to one lane (in each direction) and use the vacated area to build bicycle paths or trails. Although both VDOT and Fairfax County considered early community input to this concept, the Transportation Committee has not weighed in on the issue. The project remains “on hold” due to VDOT's moratorium.

### **Proposed Resolution to Remove Lawn Ornament from VDOT Right-of-way on Fordson Rd**

Chairman Zaragoza introduced Queenie Cox – organizer for the Virginia historical highway marker for West Ford – who led a discussion introducing a Proposed Resolution to remove the Lawn Ornament (Large Model Truck) from VDOT's Right of Way. This Lawn Ornament/Large Model Truck is currently blocking a historical marker in the Gum Springs area.

**Discussion:** Considerable debate evolved on this issue by the Committee. After pinpointing the location of this item on Fordson Road many Committee members discussed what to call it. Some members favored calling it a large model truck.

Others indicated that the large toy truck or lawn ornament had advertising lettering for a paving company. All agreed that the object was blocking West Ford's Historical Marker. Ms. Cox mentioned that the community worked hard to get the historical marker. In addition, Ms. Cox reported that efforts to contact the owner to remove the truck or lawn ornament were fruitless and being ignored. In addition, the space adjacent to this truck/ lawn ornament is now being used to park commercial trucks associated with paving and construction. Ms. Cox indicated that this is in violation of County ordinance since the land is zoned residential but is being used as commercial. Most Committee members supported removal of the object which blocks the West Ford Historical Marker. Some members, however desired to modify the wording in the resolution. Chairman Zaragoza accepted recommendations on the wording and these were accepted by the Committee. The resolution supporting removal the object (Lawn Ornament/ Large Toy Truck) which is blocking the West Ford Historical Marker was put to a vote before the Committee. The vote was overwhelming in support of the resolution to remove the object with all (10 in favor) and one (1) against. The resolution will now go before MVCCA's General Council on July 26, 2023.

## New Items:

Chairman Zaragoza opened the floor to new items for discussion. One member issued a complaint regarding the GWMP being closed on July 4<sup>th</sup> – stating that she could not get into DC to see the fireworks. She said that this applied to I-295 as well. She wondered if this was a new initiative. Others mentioned that closures had been advertised in the Washington Post for those locations several days before the 4<sup>th</sup>.

Another Committee member issued a complaint that commercial trucks were using the Parkway more and more these days. He made mention that many of the trucks had open beds and debris was splattered all over the Parkway as a

result. Another MVCCA member mentioned that Congressman Beyer was petitioning to place speed cameras on the Parkway and in addition, changing the convention that fines for Parkway violations would go back to the Parkway vice being deposited in the general fund. This, most Committee members, agreed would be a big help to Mount Vernon Communities.

## Meeting Adjourned:

Upon completion of new business, a motion to adjourn was presented and quickly seconded. Chairman Zaragoza thanked the Committee for sharing their thoughts, interest and concerns to MVCCA related topics. The MVCCA Transportation meeting concluded at 8:08 PM.

1. WHEREAS, the Virginia historical highway marker (marker) for West Ford on Fordson Road (near the intersection of Richmond Highway & Fordson Road) was unveiled on June 17, 2023; and
2. WHEREAS, the marker recognizes the founding of Gum Springs by West Ford in 1833; and
3. WHEREAS, Gum Springs celebrated 190 years of its founding with the unveiling of the West Ford marker on June 17, 2023; and
4. WHEREAS, an obstruction has been placed blocking a portion of the verbiage on the West Ford marker; and
5. WHEREAS, the closest VDOT identification plus address is PWX9+65 Hybla Valley, Virginia that is across the street from the Fairfax County water towers on Fordson Road; and
6. WHEREAS, the organizer for the installation and unveiling of the West Ford marker with support from West Ford descendants submitted a request to VDOT to remove the obstruction
7. THEREFORE BE IT RESOLVED, that the Mount Vernon Council of Citizens' Associations support the removal of the obstruction of the West Ford Historical Marker on Fordson Road (near the intersection of Richmond Highway & Fordson Road).
