MVCCA RESOLUTION (P&Z-2013-05): ON A&R HUNTINGTON METRO REDEVELOPMENT

- 1. WHEREAS, the proposed project bounded by Huntington Avenue, Biscayne Drive and Glendale Terrace on a 1-acre site is in keeping with other proposed projects in the area supported by the MVCCA;
- 2. WHEREAS, the proposed project will include 15% of work-force housing at the 80%AMI level;
- 3. WHEREAS, the proposed project will include public spaces that surround the building that may be utilized by surrounding neighborhoods;
- 4. WHEREAS, the proposed project has considered surrounding older neighborhoods by creating a townhouse look façade and tapered down structure on the sides viewed by existing neighborhoods;
- 5. WHEREAS, the structure of the proposed project will utilize energy and water saving measures through high efficiency HVAC and lighting, as well as low flow plumbing fixtures, water closets and rooftop rainwater collection,
